REVIEW REPORT TO THE BOARD OF DIRECTORS OF SWOJAS ENERGY FOOD LTD

We have reviewed the accompanying statement of unaudited financial results of SWOJAS ENERGY FOOD LTD ('Company') for the quarter ended December 31st, 2022 ('financial results') and year to date results for the period from 1st April, 2022 to 31st December, 2022 attached herewith, being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations') (the Regulation) as amended.
