Due to these events Factory Building, Machinery and other assets was damaged Taking all the necessary safety precautions, the Company shut down the plant. The loss on account of fire and flood and the loss on account of disposal of assets is considered under the head exceptional items.

The Company has single business segment i.e. Active Pharmaceutical Ingredients (API), therefore, in the context of Ind As 108, disclosure of segement information is not applicable.
