- The aforementioned results were reviewed by the Audit Committee and approved by the Boards of Directors at their respective meeting held on June 29, 2021 and also the Audit was carried out by the Statutory Auditors.
- The Company has adopted Indian Accounting Standards ("Ind As") w.e.f. 01/04/2017, The above results have been prepared in accordance with IND AS notified under the Companies (Indian Accounting Standards) Rules, 2015 as amended from time to time

Swojas has been suspended since 2000 and since then, shareholders of Swojas could not avail listing services of BSE by accessing its nationwide platform. Further, BSE had never provided any invoices for Annual Listing Fees on yearly basis for making payment even when Swojas came out of liquidation in 2015 and instead, it issued its first & only invoice of Rs 14.16 Lakhs on 26-12-2019 to seek compensation for unpaid listing fees.

There is no provision under SEBI Listing Regulations for such compensation and further, SEBI has duly clarified that it has not permitted stock exchanges to seek compensation for unpaid listing fees from listed companies. However, Hon'ble Supreme Court directed Swojas to deposit an amount of Rs 14.16 Lakhs with BSE & allowed it to also make a representation to SEBI on which speaking order will be passed by SEBI. In compliance with order of Hon'ble Supreme Court, Swojas has deposited an amount of Rs 14.16 Lakhs equivalent to compensation demanded by BSE under protest.

- The Company has only one reportable business segment and have only one reportable geographic segment in India. Segment reporting as per Ind AS 108 is not applicable.
- The figures for the quarter ended March 31, 2021 and March 31,2020 are the balancing figures between audited figures in respect of full financial year ended March 31,2021 and March 31,2020 respectively and the unaudited published year to date figures upto December 31, 2020 and March 31,2020 respectively, being the end of the third quarter of the respective financial year, which were subjected to Limited Review.
- The figures for the previous period / year have been regrouped wherever necessary to confirm to the current year's classification.
