In exercise of the powers conferred by sub-section (1) of Section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation & Resettlement Act, 2013 (No. 30 of 2013)(hereinafter referred to as "the Act"), the Government of Gujarat hereby declares that the land / lands mentioned in the Schedule annexed hereto is / are required for the purpose of acquisition for the public purpose of "For Construction of Vadnagar District Minor M.4L Subminor SM33L."
